CZECH-SLOVENIAN CONFERENCE

National LAG Network

- established in April 2007
- NGO association
- 170 Members out of 180 existing LAGs
- 13 regional networks



structure

- chairman and two vice-chairmans elected by general assembly
- **committee** consisting of 13 representatives of regions
 - meets every month in Prague and Olomouc
- workgroups on:
 - LEADER (implementation of CLLD)
 - International Cooperation
 - Public Relations
 - Programme and Vision (strategic planing)
 - Education (both schools and training of LAG-staff)

representation and partnership

- partner of 9 other national-wide organisations, 5 universities,
 3 ministeries or state agencies nad 2 networks of Slovakia
- permanent representation in 7 Monitoring Committees and 17 other workgroups, partnerships and platforms organised by different ministeries, managing authorities or government
- member of ELARD European LEADER Association for Rural Development (Czech presidency 2014 - 2015),
 ENRD - European Network for Rural Development and PREPARE - Partnership for Rural Europe

financial issues

- membership fee 400 EUR / year not eligible!
- budget of 200.000 EUR, 2/3 covered by projects
- 6 staff members (4 FTE) incl. 2 internal and 4 project possitions

our success

- nearly **100% coverage** of rural areas by LAGs
- LAG network is **considered as a partner** of ministeries and other national authorities
 - distributing information to whole network, summarizing FAQs, ...
 - organising conferences, seminars, workshops and other events
 - commenting of documents, implementing rules, etc.

- mainstreaming LEADER/CLLD in 4 Ops

- RPD Rural Development Programme (EAFRD)
- IROP Integrated Regional Operational Programme (ERDF)
- OP Employment (ESF)
- OP Environment (ERDF)
- exporting experiences and goodwill of LEADERC/CLLD
 - Croatia, Ukraine, Gruzia, Turkey, ...
