

- The selection of projects on the basis of open public tender, published by the Ministry - managing authorities
- Guaranteed fund is in the amount of 4,000,000 EUR
- · We already have one tender for 1.000.000 EUR
- Now is open second tender for 1.500.000 EUR
- We have some problems with the implementation of projects, particularly in the area of financing project from partners of LAG.
- we give MA proposals for better implementation and for change the regulations for implementing the measure.

Eligibility costs are:

- Exchange of experience and knowledge, and their implementation in the field of LAGS
- The development and marketing of services and products
- Promotion of new products, practices, processes, technology
- The integration of vulnerable groups
- The organization of joint work processes, sharing of resources and equipment
- Creating short-chain for procurement and sales of local products
- Projects related to environmental protection

Previous experience with project preparation have created the following areas for possible cooperation:

- Environment / nature / biodiversity / forest / wood
- Rural tourism
- Education / natural products
- Agriculture / local food products
- New technology / knowledge / web technology
- Cultural heritage / culture / Others

- in preparation for the conference, we invited all Slovenian LAGs to prepare project proposals
- together with the Czech LAGs today we have prepared over 20 proposals
- in the immediate preparation are already two proposals, which will be presented later.

What next?

- Look for new ways of cooperation maybe cooperation between managing authorities of LAGs
- Cooperation with other networks in Europe (Portugal, France, Croatia).
